

Internship Program

Piedmont Equine Associates is proud to offer a comprehensive program for 2 new veterinarians to gain meaningful experience while working under the guidance of eight senior clinicians including two surgeons. Interns will assist with hospital, outpatient, and ambulatory services with direct and indirect supervision as experience, confidence, and abilities grow throughout the internship year. Interns will be responsible for in-patient cases and daily treatment updates for senior veterinarians. They are exposed to a wide range of clinical cases and experiences and will be involved in every aspect of the practice as well as surgical procedures, intensive care case management, and emergency services.

The goal for the internship program at our practice is to produce a competent, well-rounded equine veterinarian in 12 months. Learning is always the primary responsibility; therefore, the intern's daily exposure to a variety of cases is essential to the experience. Piedmont Equine is a progressive practice that values new methodology and procedures. Our veterinarians value their time that is spent mentoring others in the advancement of their careers.

Internship timeline:

June 1 - May 31 of any given year. (The starting date can be somewhat changeable, but the intern is expected to begin within the first or second week of June and to be present for the full term of one year.)

Intern Duties:

Interns will rotate between the ambulatory and hospital services every 2 weeks. When on the ambulatory rotation, the intern will accompany the ambulatory doctors on their calls where they will be able to assist and perform a large variety of services ranging from preventive/routine care to lameness to reproduction to emergency care, etc. The ambulatory intern will assist with afterhours farm calls and, when ready, will see them independently. When on the hospital rotation, the intern will assist with haul-in appointments, which are varied but typically is a heavy caseload of lameness, as well as perform anesthesia and/or assist with elective surgeries. The hospital intern will assist with after-hours haul-in emergencies and hospitalized patients and, when ready, will see them independently. Overnight care of hospitalized patients will be performed by the veterinary technicians and the hospital intern with back-up if needed.

Interns will participate in topic rounds which are held every other week. The interns take turns providing informal but thorough discussions from a provided topic list. The list is extensive and covers every realm of equine veterinary practice with the purpose of exposing the interns to all aspects of the profession and the benefit of discussing with a group of seasoned practitioners.

During the breeding season, the interns work closely with the recipient mare program and manage in-house labs (cytologies, cultures, and sensitivities). Intern duties/time will be allocated based upon what is best for the intern's advancement as well as for the practice.

Emergency Duty:

The interns are provided a "skills checklist" at the beginning of the internship year. It is their responsibility to become proficient in the skills through working with the senior clinicians and getting these skills checked off. Once the checklist has been completed and as confidence and

Once the checklist has been completed and as confidence and communication skills progress, primary emergency on-call duties with decreased supervision will be assumed. Primary emergency duty with a senior clinician providing secondary coverage as needed should be expected. Primary duty will be rotated fairly between the interns.

Salary: \$36,000 per year, paid bi-weekly

Applications are accepted on a rolling basis and may be submitted at any time; we encourage, however, submission of application as soon as possible. The application deadline for a given internship year is October 1st of the preceding year (e.g., for June 1, 2026 start date, applications are due by October 1, 2025).
